The student submits a request to the study department, in which the thesis advisor's approval will be expressed, and a new binding deadline will be set. Students may submit applications on an ongoing basis to the Study Department, where they will be registered and automatically approved once all obligations have been fulfilled. The thesis supervisor must carry out a plagiarism check and decide on the credit award no later than 3 January 2024. Theses submitted after 31 December 2023 and theses for which credit is not awarded by 3 January 2024 will not be allowed to be defended at the SZZ in January 2024.
