Internship report

Time period: 27.11.2023 - 29.12.2023

Place: Tallinn University of Technology, Tallinn, Estonia

Description of activities:

From 27th of November until 29th of December I took part in the internship at the Tallinn University of Technology (TalTech) in Estonia. I was supervised by with prof. Wolfgang Dieter Gerstlberger and his colleague Mr. Tarmo Tuisk, from Sustainable Value Chain Management Unit at the Department of Business Administration, School of Business and Governance.

The internship stay was very useful for my academic career. I extended my expertise on topics of sustainability and innovations, and established valuable connections.

I was actively working on my PhD thesis, while consulting my progress with my supervisor, prof. Viktor Prokop, as well as with prof. Gerstlberger and Mr. Tuisk. I prepared a 10-page draft with aim and data analysis, which I submitted to my supervisor. I also worked on my next publication on topic of sustainable innovations, adding title, aim, short introduction and theoretical background for it. Besides that, I finished and submitted three essays for a compulsory subject "Regional Economics and Policy", taught by prof. Hudec. We regularly had online calls with prof. Viktor Prokop, discussing the progress with tasks, we also had a constant email communication.

Apart from working on my research, I attended seminars at the host university. Namely the research seminar of Department of Economics and Finance, seminar on international exchange opportunities for researchers, and seminar on research grants by Estonian Research Agency. In addition, I attended a private consultation on funding for researchers, which was offered to me by the research coordinator of the department. I participated in online monthly meeting of PhD researchers at the Department of Business Administration, where I proposed my idea of our common future paper to my supervisors at TalTech, and their PhD students. I was also invited and attended some informal meetings with other PhD students and members of the department.

We agreed with Mr. Tuisk and prof. Gerstlberger on a further cooperation on scientific publications and participating and cooperating in EU projects. Mr. Tuisk presented me the TalTech Journal of European Studies, which is edited by him and other members of the School of Business and Governance at TalTech. Mr. Tuisk invited me and other researchers at University of Pardubice to publish in this journal.
